Nominating Committee Report: President Afifi provided a report on behalf of the Nominating Committee. Second Vice President Candidate, Tina, M. Harris from Louisiana State University addressed the LA for five minutes.

Proposed New Interest Group: President Afifi recognized Lauran Bruns from the University of South Carolina, Columbia to speak on behalf of the submitters of the proposed Death and Dying Division.

• A motion was made to add the Death and Dying Division as one of NCA's Interest Groups. Seconded. Discussion ensued. Motion carried.

Information Item: Afifi announced the formation of an Ad-Hoc Ethics committee established by the Executive Committee on behalf of the Legislative Assembly to investigate a member of the Legislative Assembly who is mentioned in an ongoing lawsuit to review allegations and provide any recommendations.

Proposed Bylaws Amendment: Article V: Section 9: Convention Committee.

President Afifi provided a summary of the proposed bylaws amendment.

Article V: Standing Committees

Section 9: Convention Committee.

- A. Members. The Convention Committee shall consist of <u>a Chair and five</u> six members elected by the Legislative Assembly from a slate of candidates developed by the Leadership Development Committee. <u>The NCA Second Vice President shall serve as ex-officio</u>. The Chair shall be selected <u>by the members of the Convention Committee</u> from among the firstand second-year members <u>of the Convention Committee</u> to serve a term of one year. Convention Committee members shall have staggered three-year terms.
- B. Duties. The Convention Committee shall be responsible for providing recommendations on issues related to <u>the</u> convention <u>location</u>

A motion was made to approve the bylaws amendment. Seconded. Discussion ensued. Motion carried.

Proposed Bylaws Amendment: Article V: Section 8: Resolutions Committee

President Afifi provided a summary of the proposed bylaws amendment.

Article V: Standing Committees

Section 8: Resolutions Committee.

A. Members. The Resolutions Committee shall consist of <u>a Chair and five</u> <u>six</u> members elected by the Legislative Assembly from a slate of candidates developed by the Leadership Development Committee. The Chair shall be selected <u>by the members of the Resolutions</u> <u>Committee</u> from among the first- and second-year members <u>of the Resolutions Committee</u> to serve a term of one year. Resolutions Committee members shall have staggered three-year terms.

B. Duties. The Resolutions Committee shall be responsible for reviewing proposed public statements and providing related recommendations to the Legislative Assembly.

A motion was made to approve the bylaws amendment. Seconded. Discussion ensued. Motion carried.

Closing remarks: Afifi provided closing remarks.

One of the violences within an individualist, capitalist system in which you all work and exist is the expectation that we label us as individuals without regard to the weight we are carrying as individuals -- or that our communities are carrying -- as many of you in the room know intimately in your own ways. I want to name this violence and honor the fact that indigenous, liberatory, community focused approaches do exist and offer alternatives that I hope we seriously consider moving forward. I do my best to resist the thirst for judgement from people who are not living through ongoing violence and displacement that my community is experiencing. Nor what it takes to simply exist in this moment. Thank you to those of you who have held others during this time including myself and those carrying this weight. I offer my care and my hand whenever possible.
