IV. Vice-Chair's Report

- A. Submissions/acceptances
 - a. Last year we had 19 slots. This year we have 18 slots (including our business meeting), so in total we have 17 slots for panels and papers
 - b. 54 papers were submitted this year (down from last year); not too surprising considering COVID concerns; we accepted 43 papers (79% acceptance rate); 11 paper sessions total
 - c. 8 panel submissions, accepted 6 panels (one will be withdrawing due to a lack of participation from panel members); leaving 5 panel sessions total
 - d. 4 slots this year received co-sponsorship
 - i. 2 paper sessions (advocating for change & inclusivity – activism and social justice division); (communicating resilience – student section)
 - ii. 2 panels (renewal of vows – PR division); (transforming applied qualitative research in the time of COVID-19 – instructional development division)
