Jane Jorgenson, University of South Florida

I am pleased to be considered for nomination as an At-Large Member of the Committee on Committees. As a faculty member at the University of South Florida for more than twenty years, I have taught in the areas of organizational and family communication. My research has focused on developing more integrated perspectives on work and family conflicts, and has been energized by interdisciplinary collaborations and border-crossing between different NCA divisions.
